### Armed Robbery-Royal Community

On July 17, 2014 just after Midnight the Sumter County Sheriff's Office responded to the area of CR 462 and CR 235 within Sumter County in reference to a subject being robbed and shot in the face. Upon arrival deputies drove up on a white Dodge Ram 1500 pickup truck with a white male lying just outside the open driver's side door. The truck had a Domino's Pizza sign attached to it. The driver / victims face was covered with blood and he was lying on his stomach. The victim, identified as Jack Sickman age 46 of Lake Panasoffkee Fl. advised he was making a pizza delivery. When he arrived at the location he was immediately met by two black males in their mid 20's, 5'6 – 5'8 tall, slim built, wearing white T-shirts, with bandannas covering their face. One of the suspects was armed with a black barrel long rifle. One suspect demanded money. When the victim refused the suspect shot through the driver's side window sticking the victim in the face. The suspects then pulled the victim from the truck and took an undetermined amount of cash from his front pants pockets. They also took two pizzas, and a two liter bottle of Sprite. The suspects were last seen running east bound from the scene towards CR 235. Jack Sickman was transported by Rural Metro ambulance to Ocala Regional Hospital for treatment and was in stable condition.
