UPDATE

The Sumter County Sheriff's Office jointly with the Florida Regional Fugitive Task Force - including investigators from the U.S. Marshals Service, the Alachua County Sheriff's Office, the Marion County Sheriff's Office, and the Gainesville Police Department, arrested Antwan Deon Williams 34, of Oxford and Traci Hutcheson 30, of Center Hill for outstanding felony warrants in connection with the recent Webster shootings.

At approximately 9:25 AM this morning investigators approached a Lake Panasoffkee residence located at 1329 CR 481A where the pair were believed to be held up. Both suspects were taken into custody without incident and transported to the Sumter County Sheriff's Criminal Investigations Division for questioning.

As a precaution Lake Panasoffkee Elementary school was placed on lock down, this lasted approximately 40 minutes until the suspects were taken into custody due to the arrests taking place within close proximity to the school.
